**COMPLAINT**

1. This action is brought by the United States to reduce to judgment Matthew and Kathleen Feshbach’s (“Defendants”) unpaid income tax liability for tax year 2001.

2. This action is authorized and requested by a delegate of the Secretary of the Treasury, and is brought at the direction of the Attorney General of the United States. 26 U.S.C. § 7401.

3. This Court has jurisdiction over this action pursuant to 28 U.S.C. §§ 1340, 1345 and 26 U.S.C §§ 7402(a), 7403(a).

4. Venue is proper pursuant to 28 U.S.C. §§ 1391(b) and 1396 because the tax liabilities at issue accrued in this district and because the Defendants reside at 331 Cleveland Street, Apt. 404, Clearwater, FL 33755, which is within this district.

5. For tax year 2001, Defendants filed a federal income tax return as married taxpayers filing jointly. Defendants reported a total tax liability of \$3,247,239 but did not remit payment of that tax in full.

6. On June 17, 2002, a delegate of the Secretary of the Treasury assessed the income tax liability Defendants reported on their 2001 return, as well as an applicable penalty for failure to pay tax and interest as described below:

7. A delegate of the Secretary of the Treasury properly gave notice of the liability described in paragraph 6 and made demand for payment.

8. Despite the notice of assessment and demand for payment, Defendants have not paid all of the assessed tax liability, or the accrued penalties and interest.

9. On April 20, 2012, Defendants obtained a chapter 7 bankruptcy discharge of certain debts, including the penalty described above. Both the bankruptcy court and this Court (District Court Judge William Jung) determined that the debtors' 2001 tax liability (and the interest thereon) was excepted from discharge by 11 U.S.C. § 523(a)(1)(C). *In re Feshbach*, 576 B.R. 660 (Bankr. M.D. Fla. 2017), *aff'd*, 594 B.R. 495 (M.D. Fla. 2018). Defendants' appeal to the Eleventh Circuit is pending.

10. The United States generally has ten years from the assessment date to bring a proceeding in court to collect an assessed tax liability unless the limitation is extended by certain actions. Here, the collection statute was extended by installment agreements and the filing of the bankruptcy petition. Consequently, this suit is timely.

WHEREFORE, the plaintiff, United States of America, requests that this Court determine and adjudge that Defendants are indebted to the United States in the total amount of \$3,533,895.05, plus statutory interest thereon as provided by law and grant such other and further relief as is just and proper, including costs of this action.

## INSTRUCTIONS FOR ATTORNEYS COMPLETING CIVIL COVER SHEET FORM JS 44

### Authority For Civil Cover Sheet

The JS 44 civil cover sheet and the information contained herein neither replaces nor supplements the filings and service of pleading or other papers as required by law, except as provided by local rules of court. This form, approved by the Judicial Conference of the United States in September 1974, is required for the use of the Clerk of Court for the purpose of initiating the civil docket sheet. Consequently, a civil cover sheet is submitted to the Clerk of Court for each civil complaint filed. The attorney filing a case should complete the form as follows:

- I.(a) **Plaintiffs-Defendants.** Enter names (last, first, middle initial) of plaintiff and defendant. If the plaintiff or defendant is a government agency, use only the full name or standard abbreviations. If the plaintiff or defendant is an official within a government agency, identify first the agency and then the official, giving both name and title.
- (b) **County of Residence.** For each civil case filed, except U.S. plaintiff cases, enter the name of the county where the first listed plaintiff resides at the time of filing. In U.S. plaintiff cases, enter the name of the county in which the first listed defendant resides at the time of filing. (NOTE: In land condemnation cases, the county of residence of the "defendant" is the location of the tract of land involved.)
- (c) **Attorneys.** Enter the firm name, address, telephone number, and attorney of record. If there are several attorneys, list them on an attachment, noting in this section "(see attachment)".
  
- II. **Jurisdiction.** The basis of jurisdiction is set forth under Rule 8(a), F.R.Cv.P., which requires that jurisdictions be shown in pleadings. Place an "X" in one of the boxes. If there is more than one basis of jurisdiction, precedence is given in the order shown below.  
 United States plaintiff. (1) Jurisdiction based on 28 U.S.C. 1345 and 1348. Suits by agencies and officers of the United States are included here.  
 United States defendant. (2) When the plaintiff is suing the United States, its officers or agencies, place an "X" in this box.  
 Federal question. (3) This refers to suits under 28 U.S.C. 1331, where jurisdiction arises under the Constitution of the United States, an amendment to the Constitution, an act of Congress or a treaty of the United States. In cases where the U.S. is a party, the U.S. plaintiff or defendant code takes precedence, and box 1 or 2 should be marked.  
 Diversity of citizenship. (4) This refers to suits under 28 U.S.C. 1332, where parties are citizens of different states. When Box 4 is checked, the citizenship of the different parties must be checked. (See Section III below; **NOTE: federal question actions take precedence over diversity cases.**)
  
- III. **Residence (citizenship) of Principal Parties.** This section of the JS 44 is to be completed if diversity of citizenship was indicated above. Mark this section for each principal party.
  
- IV. **Nature of Suit.** Place an "X" in the appropriate box. If there are multiple nature of suit codes associated with the case, pick the nature of suit code that is most applicable. Click here for: [Nature of Suit Code Descriptions](#).
  
- V. **Origin.** Place an "X" in one of the seven boxes.  
 Original Proceedings. (1) Cases which originate in the United States district courts.  
 Removed from State Court. (2) Proceedings initiated in state courts may be removed to the district courts under Title 28 U.S.C., Section 1441.  
 Remanded from Appellate Court. (3) Check this box for cases remanded to the district court for further action. Use the date of remand as the filing date.  
 Reinstated or Reopened. (4) Check this box for cases reinstated or reopened in the district court. Use the reopening date as the filing date.  
 Transferred from Another District. (5) For cases transferred under Title 28 U.S.C. Section 1404(a). Do not use this for within district transfers or multidistrict litigation transfers.  
 Multidistrict Litigation – Transfer. (6) Check this box when a multidistrict case is transferred into the district under authority of Title 28 U.S.C. Section 1407.  
 Multidistrict Litigation – Direct File. (8) Check this box when a multidistrict case is filed in the same district as the Master MDL docket.  
**PLEASE NOTE THAT THERE IS NOT AN ORIGIN CODE 7.** Origin Code 7 was used for historical records and is no longer relevant due to changes in statute.
