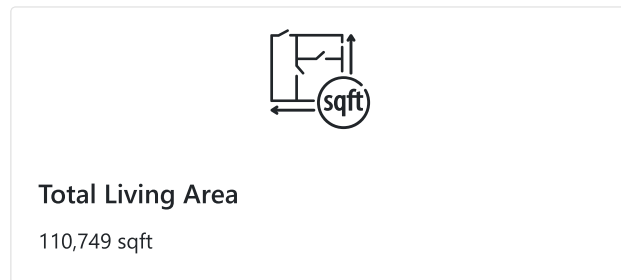

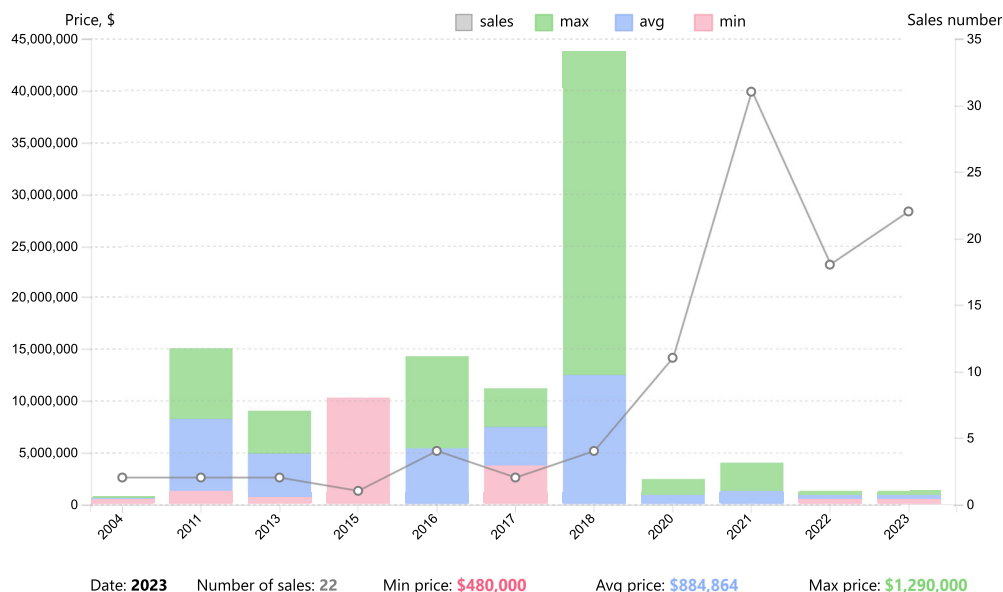

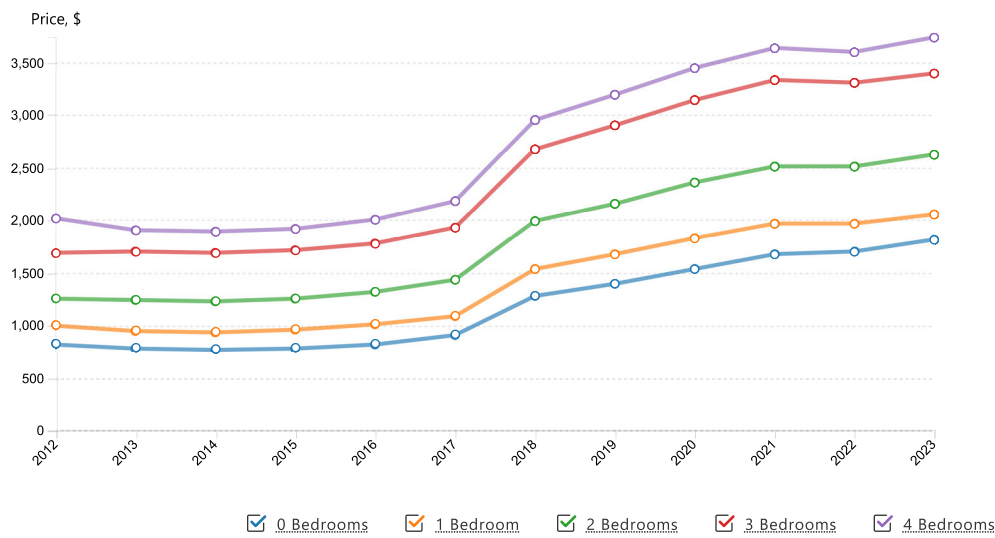

The graph shows how the Fair Rent Value changes over time

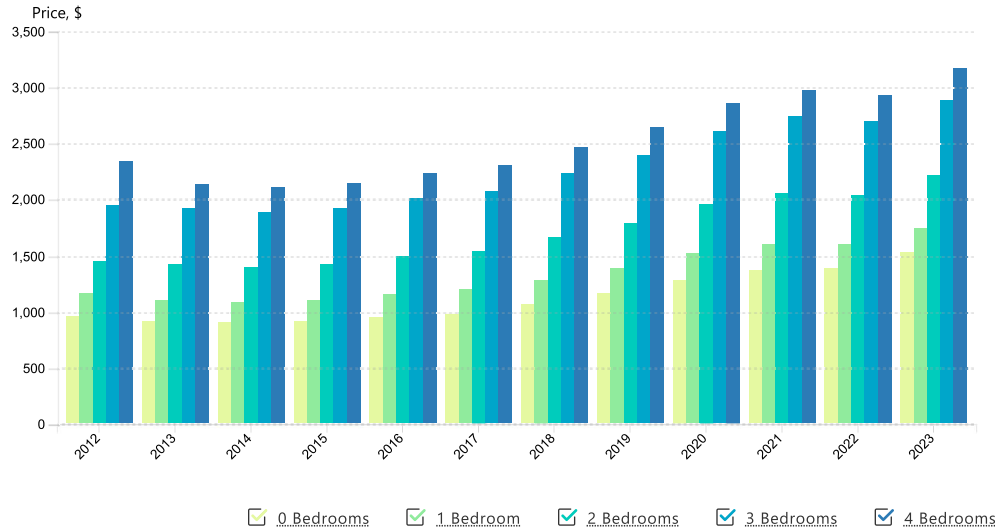

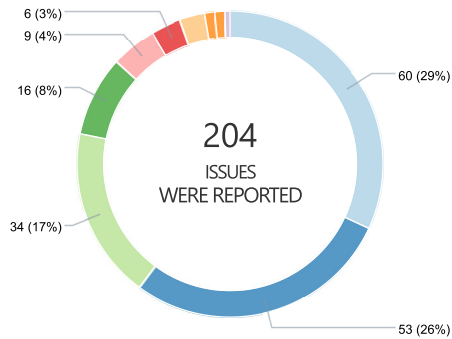

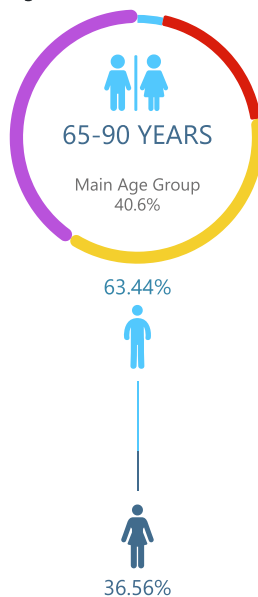

The graph shows the distribution of age groups in the neighborhood based on data for the 500 households located nearby



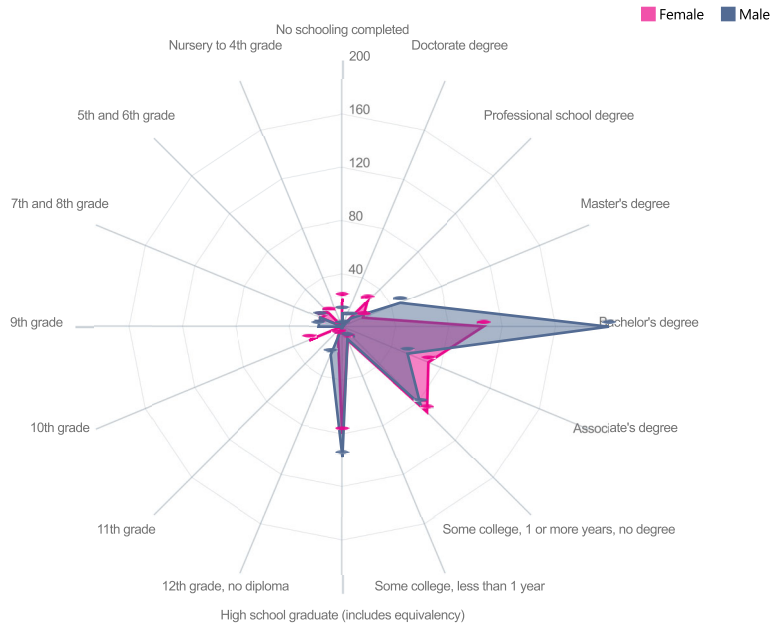

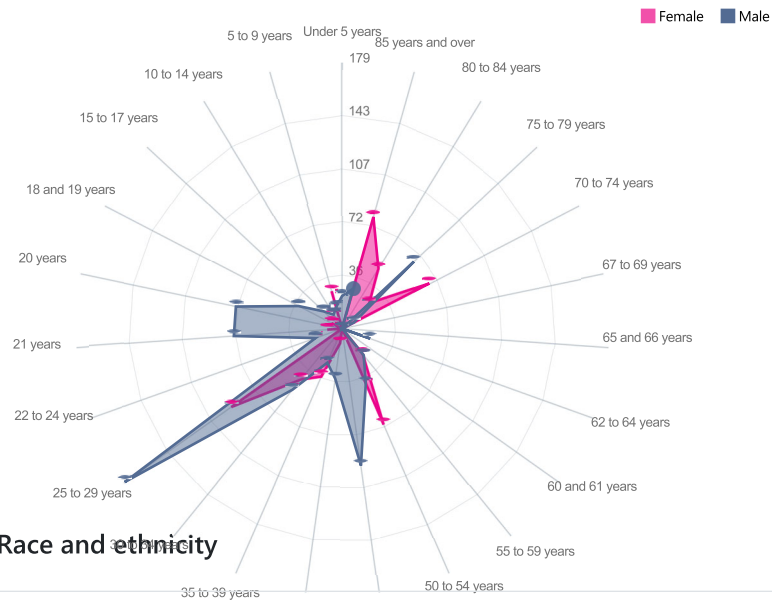

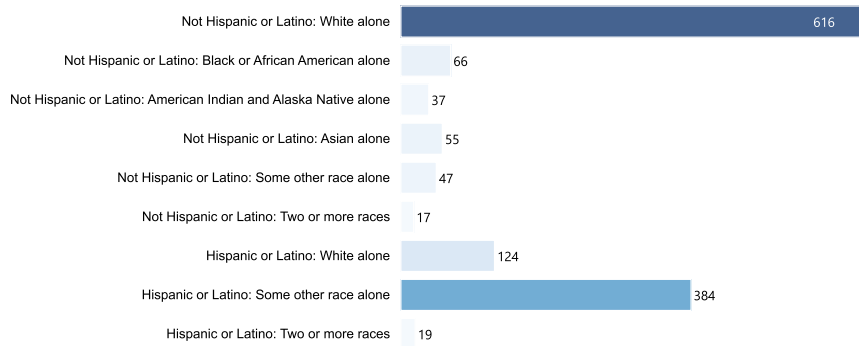

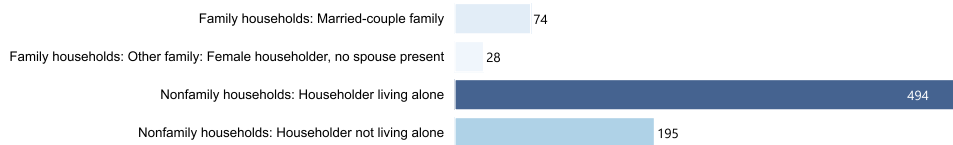

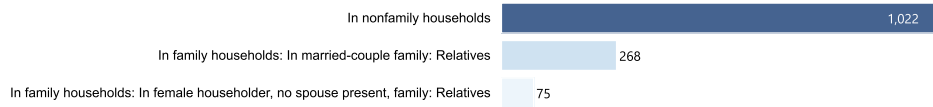
