1. INTRODUCTION

1.1 - The Company

Peacecoin, INC (the "Company") is a product-oriented company that facilitates sales of products and services to consumers through retail establishment, manufacturing, catalog, and internet sales, as well as affiliate sales in the Great State of California. All parties agree all jurisdiction belongs to the Great State of California. The main products are Solid Silver Coins, Solid Gold Coins and Solid Platinum Coins which are marketed and sold by PEACECOIN INC. and manufactured by Peacecoin Jewelry Inc. website including direct to customer sales at Peacecoin.io and Peacecoinjewelry.com.

1.2 -Code of Ethics

Peacecoin, (hereafter "Peacecoin" or "the Company") is a valued-based company that prides itself on its unique platform, the quality and character of its Partners, Staff, Customers and Affiliates (hereinafter "Affiliate"). The following guidelines help ensure a uniform standard of excellence throughout our organization. This Code of Ethics covers the legal responsibilities of all participant Affiliates of the Peacecoin Platform. Every Peacecoin Affiliate 3rd party seller is also expected to conduct a fair, legal, moral and ethical business code, be respectful of every person while conducting Peacecoin related business to customer. That they are not to engage in activities that would bring disrepute to Peacecoin Inc. or Peacecoin Jewelry Inc; and any Peacecoin corporate officers or employees, themselves or other Affiliates or Customers. That they are not to make discouraging or disparaging claims toward the product (Silver, Gold, and Platinum) as an investment commodity. Peacecoin Jewelry is simply limited edition solid Silver Gold and Platinum Coin Jewels. Peacecoin Affiliates by ensuring that in all Peacecoin business dealings they will refrain from engaging in negative language or make any type of slanderous statements or wishful claims. 3rd party Sellers and Affiliates are expected to provide support and encouragement to their Customers and Affiliates to ensure that their experience with Peacecoin is always positive. The Peacecoin compensation plan is generous and does not need exaggeration or embellishments. Peacecoin Affiliates are to represent correctly and not exaggerate any of the bonuses or compensation available through Peacecoin for 3rd Party Sellers or Affiliates and the income potential represented there in.

- It is prohibited to make any income claims or talk about 3rd Party Sellers or Affiliate compensations in public.
- It is prohibited to use your own income as an indication of others' potential success, or use compensation checks as marketing materials
- Since a 3rd Party Seller or Affiliate is not a registered financial agent, it is prohibited to represent PEACECOIN jewelry as a Minted Coin or a Government Back Silver Coins. PEACECOINS made from Solid Silver, Solid Gold, and Solid Platinum are Jewelry items only not financial instruments. They are simply for retail purpose only and represent a Movement of PEACE behind it for all human kind.

1.3 -Delays

Peacecoin shall not be responsible for delays and failures in performance of its obligations when performance is made commercially impracticable due to circumstances beyond its reasonable control. This includes, without limitation, strikes, labor difficulties, riot, war, fire, flood, and death, curtailment of a party's source of supply, or government decrees or orders. This is also not limited to the Availability of Solid Silver, Gold, and Platinum bars in kilos needed for coin Pressing and Manufacturing

1.4 -Policies and Provisions Severable

If any provision of the Agreement in its current form or as may be amended, is found to be invalid, or unenforceable for any reason, only the invalid portion(s) of the provision shall be severed and the remaining terms and provisions shall remain in full force and effect and shall be construed as if such invalid or unenforceable provision never comprised a part of the Agreement.

1.5 -Waiver

The Company never gives up its right to insist on compliance with the Agreement and with the applicable laws governing the conduct of a business. No failure of Peacecoin Inc. to exercise any right or power under the Agreement or to insist upon strict compliance by a 3rd Party Seller or Affiliate with any obligation or provision of the Agreement, and no custom or practice of the parties at variance with the terms of the Agreement, shall constitute a waiver of Peacecoin's right to demand exact compliance with the Agreement. Waiver by Peacecoin can be effectuated only in writing by an authorized officer of the Company.

2.1 -Peacecoin Membership or Non-Membership

2.2 -New Registration by the Internet and

A prospective Affiliate or Customer or Member of the Peace Movement may self-enroll on the main website at www.peacecoin.io.

In such event, instead of a physically signed agreement, Peacecoin will accept the agreement by simply ACCEPTING the "electronic signature" stating the new Affiliate or Customer has accepted the terms and conditions of this agreement. Please note that such electronic signature constitutes a legally binding agreement between the Member and Peacecoin Inc. The Company reserves the right and at its sole discretion to accept or refuse all Affiliate and Customer applications and later amend or discontinue it if any member does not show proper and good will behavior.

2.3 -Requirements to Become a Member of the Peacecoin Movement or 3rd Party Seller or Affiliate

To become a Peacecoin Peace Movement Member or 3rd Party Seller or Affiliate, each applicant must:

- Be at the age of majority in his/her state of residence.
- Reside in the United States of America or other countries, which have been officially opened by Peacecoin Inc. and the Peacecoin Movement. Which now Includes ALL Nations of the World.
- Have a valid Social Security Number (SSN), Federal Tax Identification Number or appropriate Tax Identification Number for your location if the Member wants to enroll as a 3rd Party Seller or Affiliate.

2.4 -Peacecoin Customers

Peacecoin Customers are sold Silver, Gold and Platinum jewelry coins, and designer Apparel for man and women. Peacecoin Customers must be:

- Be at the age of maturity in his/her state of residence and understand that he/she is buying or purchasing precious metal products such as solid Silver Gold and Platinum.
- Reside in the United States of America or other countries and territories, which have been officially opened by Peacecoin Inc. Peacecoin Inc. ships to all territories and countries around the world.

2.4.1 –Peacecoin Customer Purchase Limitations

Customers may continue to purchase from any unlimited quantity of product and orders from Peacecoin Inc.

2.4.2 -Peacecoin Product Sales

2.4.3 –Guarantees and Market Price of Silver, Gold, & Platinum

Members submit that the Company makes no guarantee, representation or warranty as to the profitability of its products, including but not limited to its solid silver, gold, or platinum coins or other products. Members, Affiliate and Customers, hereby submit and agree that the Company's products including the silver coins and the entire line of Peacecoin Jewelry products being introduced in the future cannot be declared defective nor deceiving just because it is not surrendering the amount of money value that they or their friends said or the market was expecting for that precious metal. Market price of precious metal fluctuates and there is no guarantee your Silver, Gold, or Platinum jewelry will maintain a static value or any value for that reason. Please refer to the precious metal index to determine the value of your solid Silver, Gold, or Platinum coins. Peacecoin Inc. nor Peacecoin Jewelry Inc. have any say or jurisdiction on this value, they are simply resellers of high end custom coins and jewelry.

3 -ENDORSEMENTS OF PEACECOIN SERVICES – PEACECOINS ARE REGISTERED TRADEMARK AND COPYRIGHT OF PEACECOIN INC.

No claims as to any services offered by Peacecoin may be made except those contained in Official Peacecoin Materials.

3.1 -Non-Solicitations

If a 3rd Party Seller or Affiliate decides to no longer engage with the Peacecoin business, he/she may not for a period of 90 days in a calendar year following the cancelation of the 3rd Party Seller/Affiliate Agreement, re-engage again.

3.2 -Privacy and Confidentiality

All Customers, 3rd Party Sellers, and Affiliates and not limited to Peacecoin Movement Members are required to abide by the Company's Privacy Policy regarding being a Peacecoin Movement Member and or any 3rd Party Seller or Affiliate and or Customer information. (See Privacy Policy Below)

This is the default procedure if the parties do not agree on the formats set forth above.

- The Company will never remove a party to a position from a Peacecoin Movement Member or 3rd Party Seller or Affiliate account without that party's written permission and signature.

4 -ADVERTISING

4.1 -Adherence to Official Peacecoin Materials

Customers, 3rd Party Sellers or Affiliates and not limited to Peacecoin Movement Members must adhere to the terms of the Peacecoin trademark and copyright rights asset forth in Official Peacecoin Materials and "common sense" understanding. Customers, 3rd Party Sellers or Affiliates and not limited to Peacecoin Movement Members shall not require or encourage other current or prospective Customers to participate in the Peacecoin Movement Rallies or activities if a Customer simply chooses not to.

Customers, 3rd Party Seller or Affiliates and not limited to Peacecoin Movement Members shall not require or encourage other current or prospective Customers to execute any agreement or contract agreements and contracts from the introduction of Customer through its products. Peacecoin Customers are the rights of Peacecoin Inc. and are prohibited to be solicited to outside of PEACECOIN INC. Jewelry Products or Services.

Customers of Peacecoin Inc. are only allowed to purchase their products through authorized Peacecoin Inc. retail shops or ecommerce website(s)

4.2 -Domain Names and Email Addresses

Customers, 3rd Party Sellers or Affiliates and not limited to Peacecoin Movement Members MUST not use or attempt to register or sell any of Peacecoin's trade names, trademarks, service names, service marks, product names, or any derivative thereof, for any internet domain name or email address.

4.3 -Media and Media Inquiries

All inquiries by any type of media must be immediately referred to Peacecoin Inc.. This policy is designed to ensure that accurate and consistent information is provided to the public, as well as a proper public image.

4.4 -Retail Establishments

Company products may only be displayed and sold in retail establishments where the nature of the business is to make appointments with Customers where appointments are made for personal training or classes are scheduled. Only authorized Retailers can sell Peacecoins.

The sale of such products or services within such retail facilities must be conducted by a Sales Agent and must be preceded by a discussion where the Sales Agent introduces the Company's products by Peacecoin Jewelry Inc. employees or specialists only. Company produced literature, banners, or signage only may be displayed on a shelf, counter, or wall and must be displayed made in compliance and according to Peacecoin Jewelry Inc. requirements, standards, and guidelines only. Company products may not be sold from a shelf by any unauthorized retailers, anywhere.

5 -PURCHASE PAYMENTS AND AUTOMATIC BILLING

5.1 -Purchase Payments

All product payments to Peacecoin Inc. or Peacecoin Jewelry Inc. are made through the company website or ecommerce portals.

5.2 -Payments and Automatic Billing

5.2.1 -Affiliate Automatic Qualification

For Customers who wish to ongoing re-purchase of Peacecoins, can be set to automatic billing and credit card processing if approved and opted in by customer himself at time of purchase. Customer can at any time without any reason and at any notice cancel his/her auto recurring payment for any Silver Gold or Platinum solid silver coin jewelry purchases.

6 -ERRORS OR QUESTIONS

If any Customer has questions about or believes any errors have been made regarding their purchase, or charges, or changes to shipping information or purchase status, he/she may contact Peacecoin Inc. at the customer service number listed on the ecommerce website or email to company directly at contact@peacecoin.io within the first 30 days of their purchase. Peacecoin Inc. or Peacecoin Jewelry Inc. will not be responsible for any errors, omissions, or problems not reported to the Company after the 30 days (from purchase).

7 -CANCELATION

A Customer has a right to cancel at any time within the first 14 days of purchase of products, regardless of reason. Cancellation must be submitted in writing via email or registered mail to the Company at contact@peacecoin.io.

8 -DISPUTE RESOLUTION

8.1 -Mediation

Prior to instituting arbitration, the parties (Customer and Company or 3rd Party Seller or Affiliate Member or Peacecoin Movement Member) shall meet in good faith and attempt to resolve any dispute arising from or relating to the Agreement through non-binding mediation. One individual who is mutually acceptable to the parties shall be appointed as mediator. The mediator's fees and costs, as well as the costs of holding and conducting the mediation, shall be divided equally between the parties. Each party shall pay its portion of the anticipated shared fees and costs at least ten (10) days in advance of the mediation. Each party shall pay its own costs and individual expenses associated with conducting and attending the mediation. Mediation shall be held in Glendale, California, and shall last no more than two (2) business days.

8.2 -Arbitration

If mediation is unsuccessful, any controversy or claim arising out of or relating to the Agreement, or the breach thereof, shall be settled by confidential arbitration administered by the American Arbitration Association under its Commercial Arbitration Rules, and judgment on the award rendered by the arbitrator may be entered in any court having jurisdiction thereof. CUSTOMERS, 3rd Party Seller, Affiliate Member or Peacecoin Movement Member waive all rights to trial by jury or to any court. All arbitration proceedings shall be held in Los Angeles, California. All parties shall be titled to all discovery rights pursuant to the Federal

Rules of Civil Procedure. There shall be one arbitrator, an attorney at law, who shall have expertise in business law transactions with a strong preference being an attorney knowledgeable in the Peacecoin Inc. and Peacecoin Jewelry Inc. or the business of Jewelry business; of which is selected from the American Arbitration Panel. The decision of the arbitrator shall be final and binding on the parties and may, if necessary, be reduced to a judgment in any court of competent jurisdiction. This agreement to arbitration shall survive any termination or expiration of the Agreement.

Nothing in these Policies and Procedures shall prevent Peacecoin Inc. from applying to and obtaining from any court having jurisdiction a writ of attachment, a temporary injunction, preliminary injunction, permanent injunction, or other relief available to safeguard and protect and business of Peacecoin Inc. or Peacecoin Jewelry Inc. and interest prior to, during, or following the filing of any arbitration or other proceeding or pending the rendition of a decision or award in connection with any arbitration or other proceeding.

8.3 -Governing Law, Jurisdiction and Venues

jurisdiction and venue of any matter not subject to arbitration shall reside exclusively in Los Angeles, The Great State of California. The Federal Arbitration Act shall govern all matters relating to arbitration. The laws of California shall govern ALL other matters relating to or arising from the Agreement.

9 -ANTI-SPAM POLICY

9.1 -Zero Tolerance

Peacecoin has a ZERO TOLERANCE Anti-SPAM policy. Any account found to be using Peacecoin for spam will be suspended without notice. If you know of or suspect any violators, please notify us immediately at Contact@peacecoin.io. Peacecoin Inc. and Peacecoin Jewelry Inc. is a strong supporter of a spam-free communication environment.

9.2 -What is Spam?

Spam is any type of unsolicited commercial electronic messages. By sending messages to only those who have explicitly requested to receive it, you are following accepted permission-based messaging guidelines. You should not assume a preexisting relationship to be a substitute for explicit consent to send messages. For example, if your Customer disclosed a mobile number in a normal course of business but did not specifically express consent to receive your message, you cannot send messages to the number.
